

Add item 254 Pavement Planing to typical and quantities. Added.

2. Show one foot berm on each side of sidewalk (12:1). Added a one foot berm to each side of the sidewalk.

3. Ground line shown on typical sections do not represent actual field conditions. Revised.

4. Indicate the edge of pavement follows a curve between Sta. 49+86 and Sta. 51+25. Possibly show curve radius and P.T. Station. *Added*.

5. Add pavement elevations @ travel lane on intersection detail sheet. Added

6. Start vertical curve beyond edge of travel lane for Street B. Revised. Street B profile has been moved to sheet 5/14.

Two vertical curves have overlap on Street B profile. Revised. Street B profile has been moved to sheet 5/14.

8. Katherine Wilson is no longer with Duke Energy (Gas). Revised.

9. Revise Joint Seal note to replace "Pavement" with "Payment." Revised.

10. Add "Class 1" to Seeding and Mulching description. Added.

14. All sidewalk with shall be 5' minimum. Revised.

12. Revise alignment of curb ramps to better align crossing. Revised.

13. Since curb and gutter is Butler County std., the transition height of curb is 4", not 6". Revised.

14. On Traffic Control Plan, remove all references and line work pertaining to temporary easements. Plan can show existing and proposed right of way (Reduce clutter). Removed.

15. Label existing lane widths at project limits. Added.

16. Label End Taper at Sta. 54+87. Added.

17. Revise STOP sign to 36"x36". Revised.

18. Proposed crosswalk should be "piano key" style (12" width, 4' on center). Revised.

19 Move bull nose back about 10' to accommodate EB left turning vehicles. Revised.

20. Eliminate transverse markings on the north side of intersection. Removed.
