Good morning, Mark.

Since the counts are over 4 years old, updated counts will be required. We will need to agree on a growth rate to determine design volumes for the 2033 horizon year.

As I told Steve during our discussion about a possible right in-right out for First Watch, it is unlikely that the access will be granted. It will need to show a notable benefit to the existing Gilmore intersection. The other access drives along this corridor connect to multiple trip generators and not a single business with the exception of Home Dept which is a very high trip generator.

I understand the attached exhibit is preliminary but the proposed right in/right out, if approved, will need to be designed to BCEO standards with a drop right turn lane.
